This privately run home provides care for up to four children who have experienced significant trauma that has resulted in a range of behavioural, emotional and social difficulties.

The manager was registered in October 2018.

This inspection

The effectiveness of the home and the progress and experiences of children and young people since the most recent full inspection

This home was judged good at the last full inspection. At the interim inspection, Ofsted judges that it has improved effectiveness.

Four requirements and one recommendation were set at the last inspection. The manager has met three of these requirements. One requirement and the recommendation are restated.

The staff understand the importance of education and providing the children with the same opportunities as their peers. The children have made good progress in their education. The level of attendance at school is high. The children have passed their exams and achieved good grades. The staff celebrated the exam results with the children. One child was able to attend her school prom.

Three children have moved out of the home. The staff understand how difficult transitions can be for children who are leaving the home. The staff work closely with the child, the social worker and the new placement to ensure that each transition is managed well.

The staff enable the children to develop their independence skills safely. The children help the staff to cook, and the staff support the children to keep their rooms tidy and to do their laundry. This helps to prepare the children for adult life.

The children know how to complain. There have been two complaints from children since the last inspection. These were resolved quickly. The children were kept updated and they said that they felt listened to and were happy with the outcome.

Children feel safe at the home. The number of incidents of children going missing from the home has decreased. The manager works closely with the local missing person's team and local police officer. The staff make detailed records when children go missing. This helps the manager to identify patterns and trends to inform strategies to reduce the likelihood of further incidents. There has been a significant decrease in physical restraints. The staff manage potentially difficult situations well without the need to regularly resort to restraint.

The children's regularly updated risk assessments are comprehensive. The information and strategies in the risk assessments help the staff to work with and keep the children safe.

The organisation has begun to use an electronic system to record and store records. This helps the manager to monitor the staff's practice and outcomes. The manager also uses the independent monthly reports to develop the service.

Safeguarding concerns are managed well. The manager reports concerns appropriately and follows advice from the designated officer and police. This protects the children.

There has been a high turnover of staff since the last inspection. These changes to staffing make it difficult for the children to build and maintain positive relationships with the adults who work with them.

The staff have undertaken the organisation's mandatory training. However, not all the staff have achieved a level 3 qualification within the required timescale.

Since the last inspection, there have been some gaps in supervision. New staff have not received fortnightly supervisions as set out in the organisation's induction plan. This means that inexperienced staff may not get the support that they need.

The home has benefited from some redecoration, and new furniture has been purchased. The children have been involved in choosing furnishings for the house. However, the home generally lacks a warm and nurturing feel.

Recommendations

- For children’s homes to be nurturing and supportive environments that meet the needs of their children, they will, in most cases, be homely, domestic environments. (‘Guide to the children’s homes regulations including the quality standards’, page 15, paragraph 3.9)

- The registered person must achieve continuity of staffing so that children's attachments are not overly disrupted, including ensuring that the employment of any temporary staff will not prevent children from receiving the continuity of care that they need. ('Guide to the children's homes regulations including the quality standards', page 51, paragraph 10.1)

In particular, build a stable staff team so that the children can develop and sustain good-quality relationships with the adults who care for them.
